2. Proof of address (Copy of your Bank statement showing your address, KRA Certificate or Utility bill e.g Electricity, Water or Telephone showing your address.

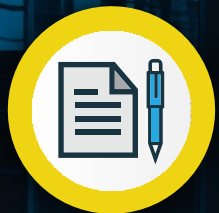
