# We will be using a MAM System

MAM stands for Multi Account Manager. This unique kind of trading setup allows investors to allocate funds to a qualified trader or money manager of their choice who in turn manages these pooled funds across multiple trading accounts. The money manager will receive a performance fee for this service which is a set percentage calculated on the trading gains. The remaining profit is distributed back to the investors according to the percentage allocation they each have in the total pool of funds.

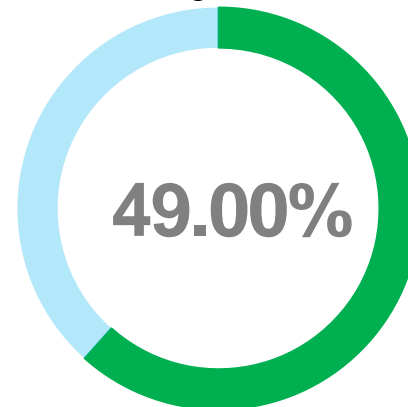

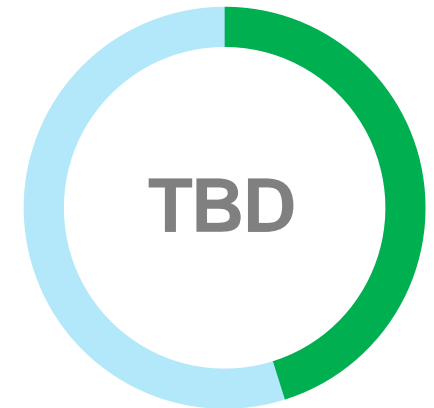

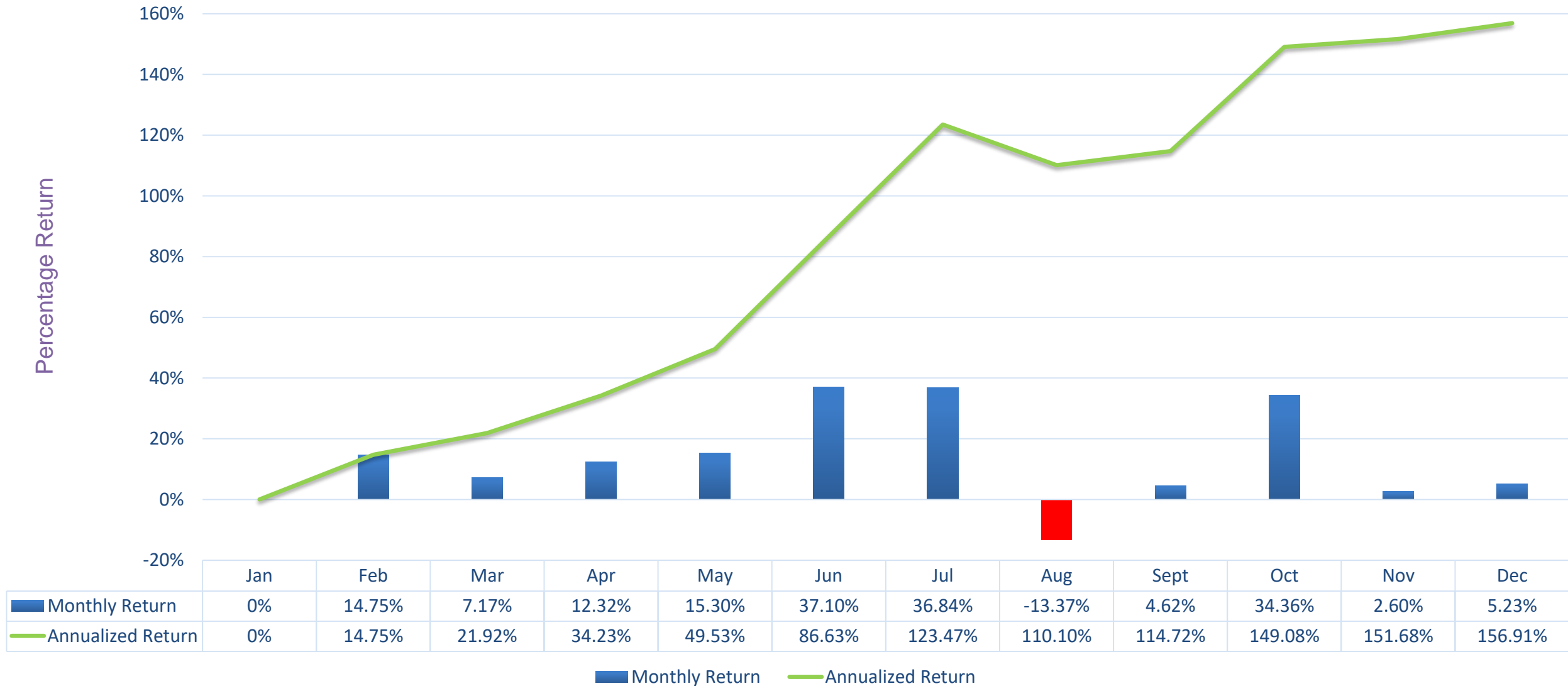

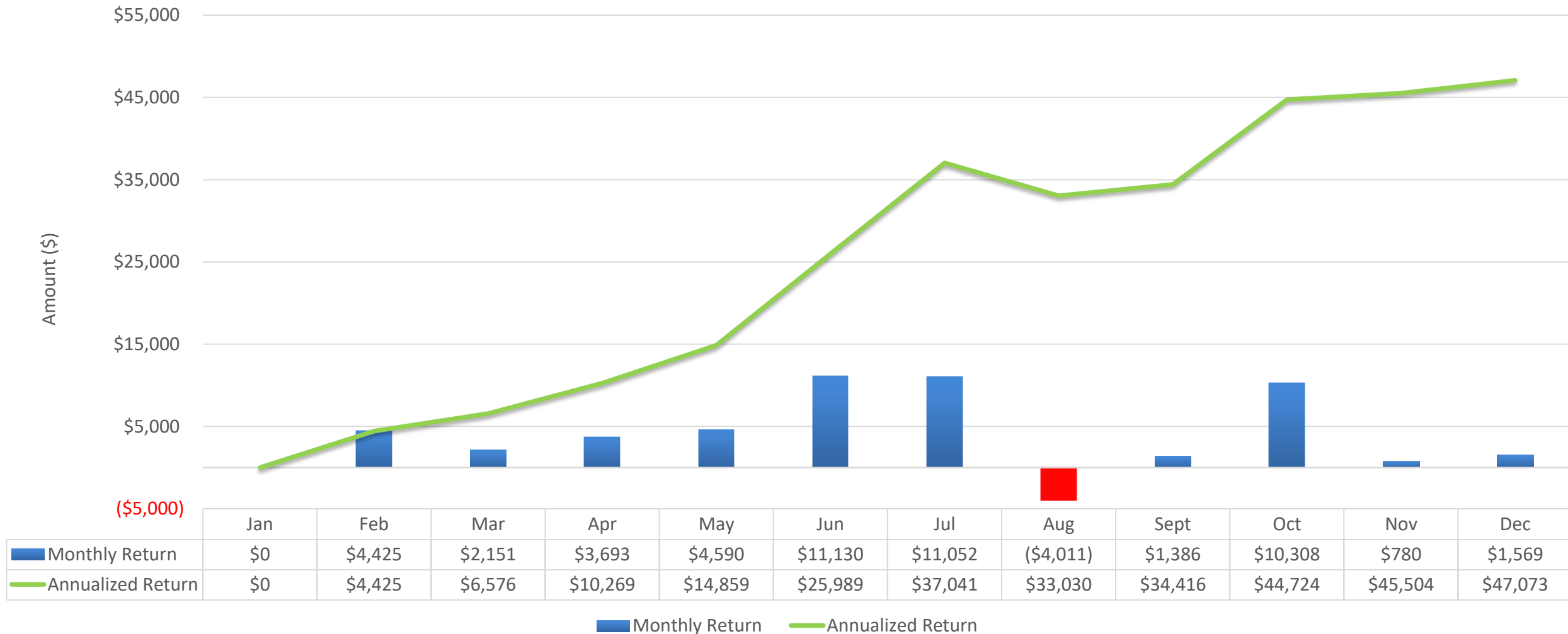
